Office of the Mayor:

Mayor Casey reported that he just returned from a Critical Event Debriefing held at OLCCHS for all people that were involved in the critical event that took the life of LT. Kouski. Several surrounding agencies responded to the call and attended the debriefing today. It was a needed event that was put together by Chief Dominguez and there is continuing counseling available to all involved. In light of the emotional day Mayor Casey stated he excused both the Chief and Director Trlak from tonight's meeting.

Mayor Casey stated it has been a very sad week for the City of Hometown. There was a DUI accident car versus pole, Public Works was called out for the pole removal, Director Trlak was there regarding the pole while LT. Kouski was directing traffic in the area. Lt. Kouski was struck by another DUI driver and succumbed to his injuries. So our whole Police and Public Works Departments were impacted. Lt. Kouski was a 34 year Veteran with the Hometown Police Department; he went through the ups and downs with the department and stayed the course.

Jim did what had to be done, he did his job. I commend and honor him, he will be missed. The Chief put together a very professional, moving emotional tribute to Lt. Kouski and the Communities support was astounding. Driving down Southwest Highway in a procession that included 78 different Departments from all over the State and seeing the residents line the street was amazing, heartwarming and emotional. Again, our Police Department and the leadership of the Chief deserves all of our admiration and respect.

Mayor Casey reported we had a good event bringing the Easter Bunny around town for the kids, out of respect for our loss of Lt. Kouski we did not have a large police escort but we also wanted to let the kids see the Bunny. As far as the election, congratulations to the re-elected officials, the turnout was dismal, 195 voters but with most all races unopposed it was to be expected.
